\$2,001 to \$25,000	\$60.00 (63.00) for the first \$2,000 plus \$9.00 (9.45) for each additional \$1,000.00 or fraction thereof, to and including \$25,000.
\$25,001 to \$50,000	\$267.00 (280.35) for the first \$25,000 plus \$6.50 (6.83) for each additional \$1,000.00 or fraction thereof, to and including \$50,000.
\$50,001 to \$100,000	\$429.50 (450.98) for the first \$50,000 plus \$4.50 (4.73) for each additional \$1,000.00 or fraction thereof, to and including \$100,000.
\$100,001 to \$500,000	\$654.50 (687.23) for the first \$100,000.00 plus \$3.50 (3.68) for each additional \$1,000.00 of fraction thereof, to and including \$500,000.
\$500,001 to \$1,000,000	\$2,054.50 (2157.23) for the first \$500,000.00 plus \$3.00 (3.15) for each additional \$1,000.00 or including \$1,000,000

Miscellaneous Fees

1. Special Inspections for buildings required to be inspected for regulated use licensing : \$100.00 (~~\$105.00~~)

2. After Hours Inspections
\$75.00 (~~\$78.75~~) per hour for inspectors' time for the work & travel to & from the site of the work, with a minimum fee based upon 2 hours per inspector.

3. Reinspection fee shall be \$ 100.00. (No change)

4. Partial, temporary or preliminary occupancy certificates:
Residential Properties -- \$10.00 (~~10.50~~) per living unit up to 4 units
All other structures -- \$25.00 (~~\$26.25~~) per certificate.

5. Elevator inspection fees - \$175.00. (No change)

6. Appeal fees - \$100.00 per appeal. (No change)
